

Terms and Conditions of Use of mybekaert.com

Legal Notices

Before registering, accessing or using any of the Extranet Sites accessed via www.bekaert.com (the "mybekaert"), please carefully review the Terms and Conditions of Use ("Terms of Use") provided below. These Terms of Use apply to and govern use of all the mybekaert. By accessing or using any of the mybekaert extranets, or by registering and maintaining a Single Sign On ("SSO") account to access the mybekaert environment, you acknowledge your careful review and acceptance of these Terms of Use. If you do not agree to the Terms of Use, you may not register or maintain an account or otherwise use or access any of the Sites or their contents.

In these terms and conditions, "you" or "your" refers to the individual registering an extranet account or otherwise accessing or using the Sites with an SSO user ID and password. If you are registering an SSO account, or are accessing or using the Site on behalf of a corporation, partnership or other business entity, "you" or "your" also refers to such business entity, including all of its officers, directors, employees, representatives and agents.

Acceptance of Terms of Use
